NARRATIVE

On 07/09/2022, I responded to 3499 Wainwright St in reference to a peace disturbance which occurred earlier.

Upon arrival I spoke to the victim, Barbra Hall and her husband William "Buddy" Hardin. Hardin advised he is running for an election and earlier in the day a subject, later identified as William Wakeman, came to his house while his wife was home and caused a disturbance. The disturbance was caught on a ring doorbell camera.

Hardin showed me the ring doorbell camera footage. In the video I noticed Wakeman was a older white male with a white beard, wearing a yellow shirt and blue jeans. Wakeman rang the doorbell and Hall answer the door. Wakeman appeared upset because he received campaign mail at his residence. Wakeman asked Hall if her husband was home. When Hall said he was not, Wakeman became agitated and stated "I cant speak to you the way I want to speak to your husband". Wakeman proceeded to yell at Hall and said " tell him to leave his pro Trump shit on his own Goddamn porch, and tell him he's a fucking treasonist, fuck republicans and fuck him and fuck your husband." Hall stated Wakeman yelled at her "I hope you get shot" and proceeded to yell that he hopes her husband gets shot and their grandchildren get shot. Hall stood on her front porch as Wakeman

walked back to his car and he turned around and yelled at her "you got a problem, Ill back up for you".

Hall called Hardin and told him what had happened and then called the police to report the incident. Hall stated Wakeman was driving a red car but did not know the make or model or know the license plate, but said it looked like a sedan. Hardin sent the ring doorbell camera footage to my department cell phone. I uploaded the videos to evidence.com.

Hardin provided the defaced piece of mail Wakeman left on their porch. It had been defaced with the writing "FUCK YOU" , "PUSSY", and "FAT PUSSY" on the mail. The mail was addressed to "The Wakeman Household" at 124 S Cadillac Dr. I captured photographs of the mail on my department issued cell phone and seized the mail as evidence. The photographs were uploaded to evidence.com.

Hall provided a written statement of the incident. The written statement was submitted into evidence and attached to this report.

Later in the evening, I drove by 124 S Cadillac Dr and observed a red Honda in the drive way. I ran the license plate and discovered it came back to William Wakeman. I requested an assist officer meet me at the address to conduct further investigation.

Officer Falzone responded to my location and together we attempted to make contact at the address. Wakeman answered the door and I recognized him as being the same subject from the video. Wakeman was wearing the same shirt as in the video. I confirmed Wakeman's identity and asked him if he was at Wainwright St earlier in the day. Wakeman stated he was. I told Wakeman he was under arrest for Peace Disturbance and instructed Wakeman to turn around and put his hands behind his back. I handcuffed Wakeman with his hands behind his back. I checked the handcuffs for proper fit and double locked them. While handcuffing Wakeman, he made the statement "Peace disturbance? Because I yelled at the lady? But them leaving their trash is okay?".

I placed Wakeman in the backseat of my patrol vehicle and seat belted him in. Wakeman was conveyed to the station without incident. Upon arrival at the station, Wakeman was escorted into the interview room.

I attempted to conduct a mirandized interview with Wakeman. I read Wakeman his constitutional rights verbatim from a department constitutional rights waiver. Wakeman declined to make a statement and signed the refusal section of the rights waiver.

Wakeman was booked and charged with Peace Disturbance and held on bond.

The constitutional rights waiver was attached to this report and submitted into evidence.

I called Hardin and advised him on how he and Hall could get an ex-parte against Wakeman if they desired.

Nothing further at this time.
