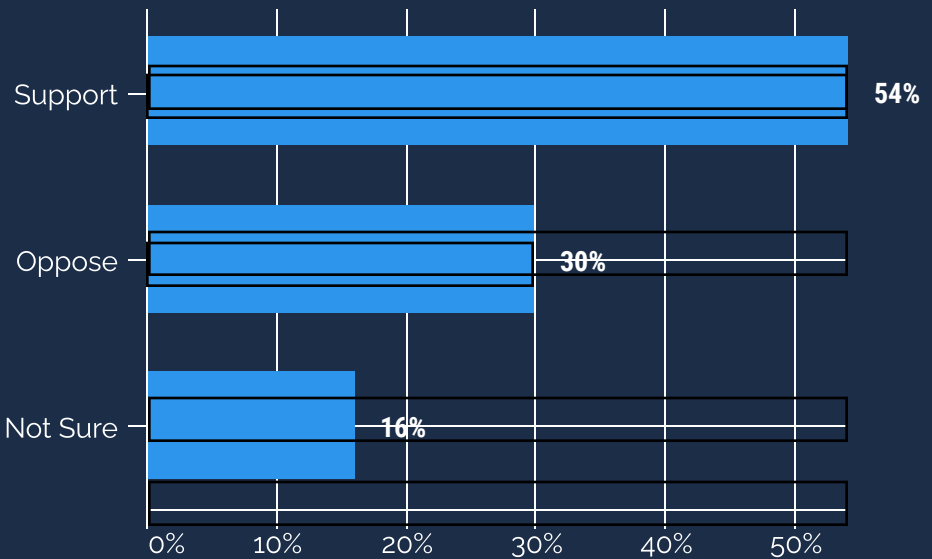

Survey conducted April 26, 2023. 1,896 likely 2024 November Election voters participated in the survey. Survey weighted to match expected turnout demographics for the 2024 November Election. Margin of Error is +/-3% with a 95% level of confidence. Totals do not always equal 100% due to rounding. Survey conducted by Remington Research Group on behalf of Missouri Scout.

Q1: There is a proposal to increase minimum wage on January 1, 2025 to \$14.00 per hour, and then increase it \$1/hour each year until 2027, when it would be \$16 per hour.

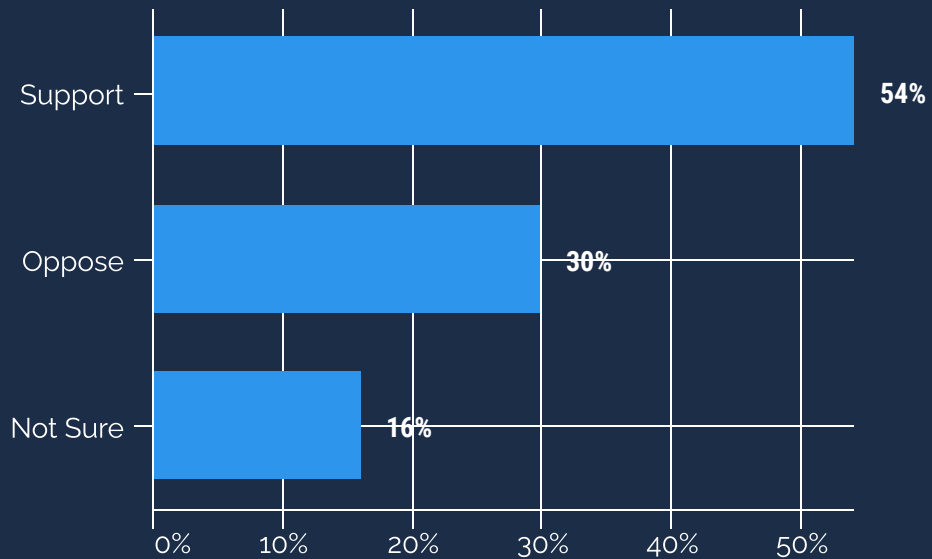

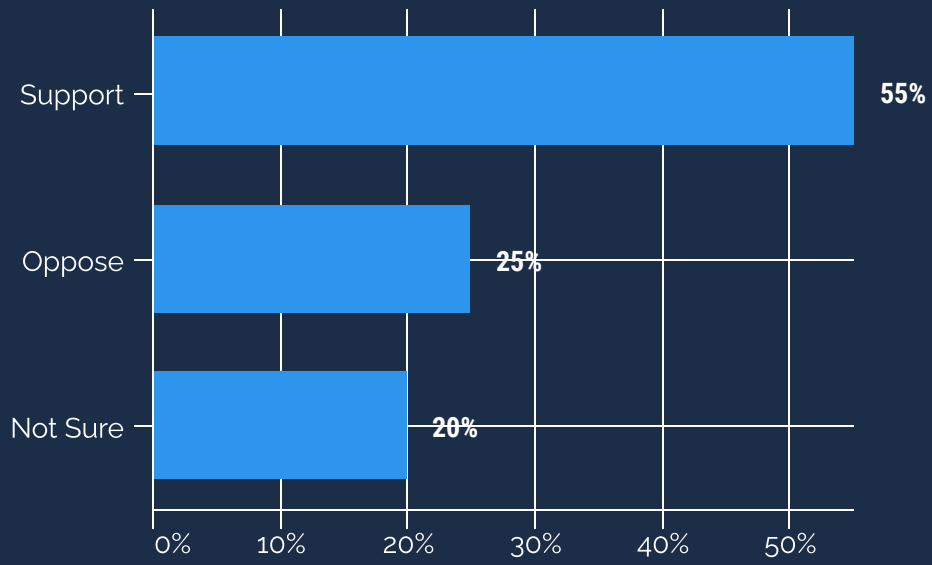

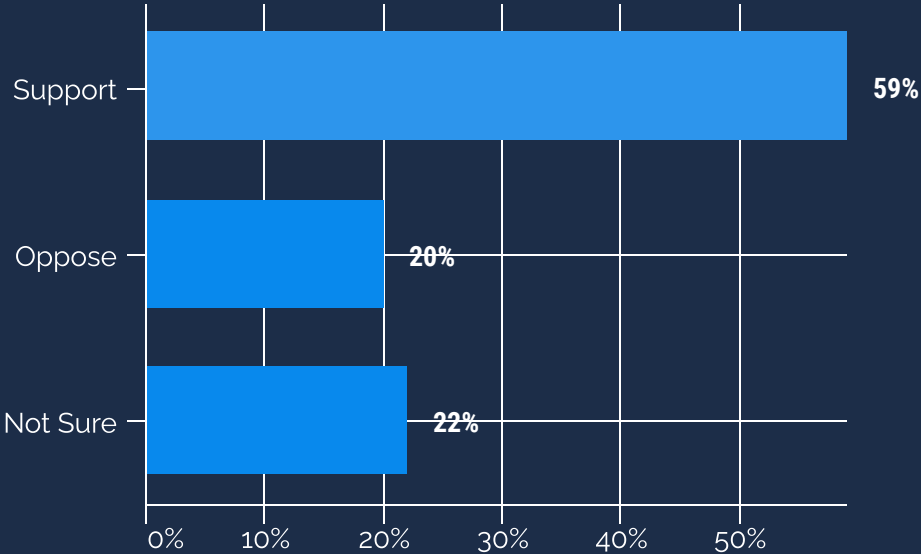

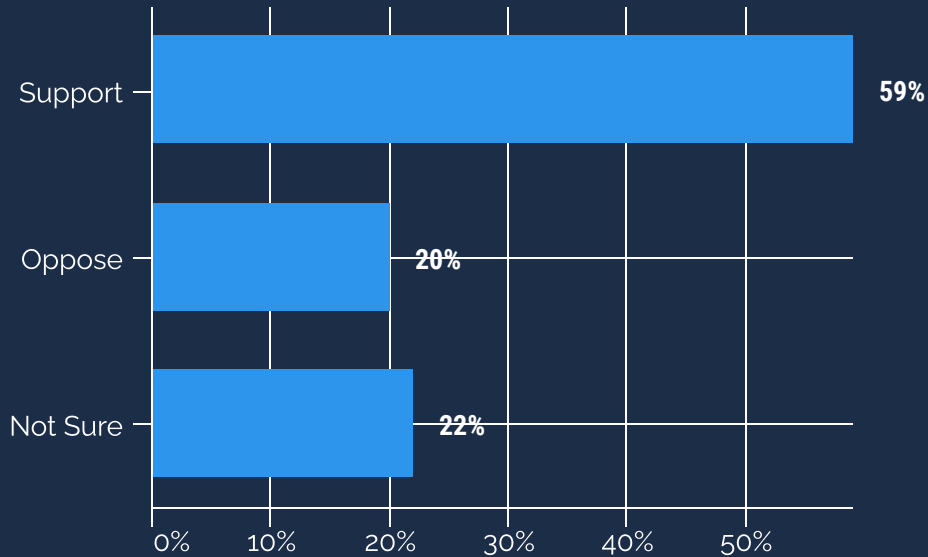

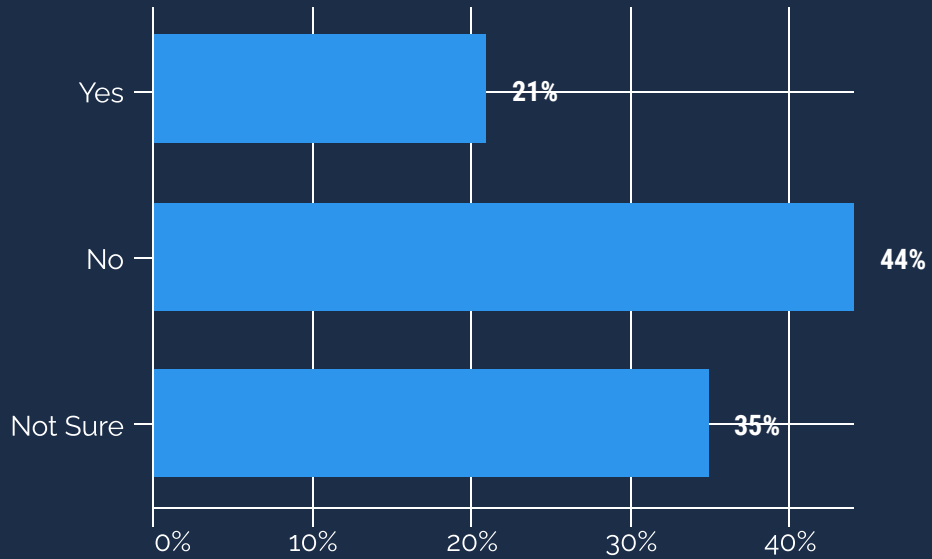

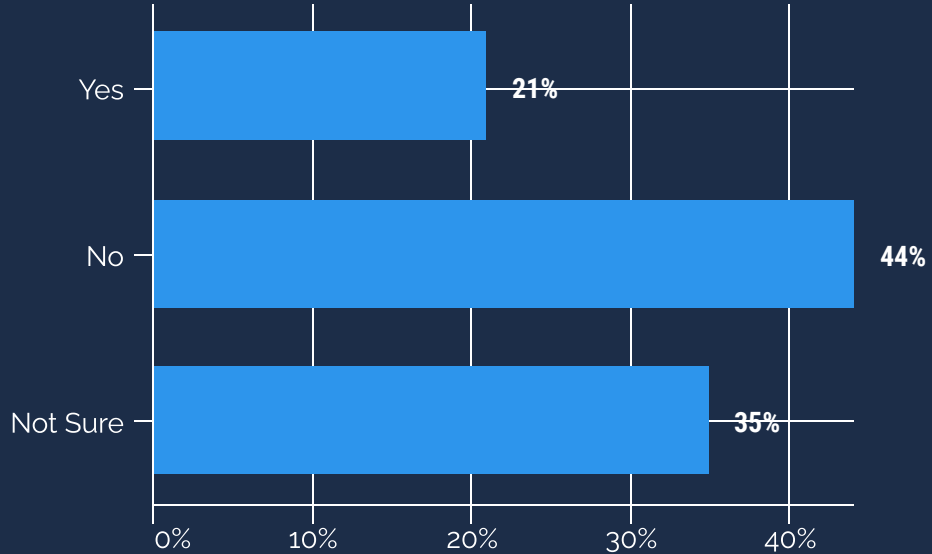

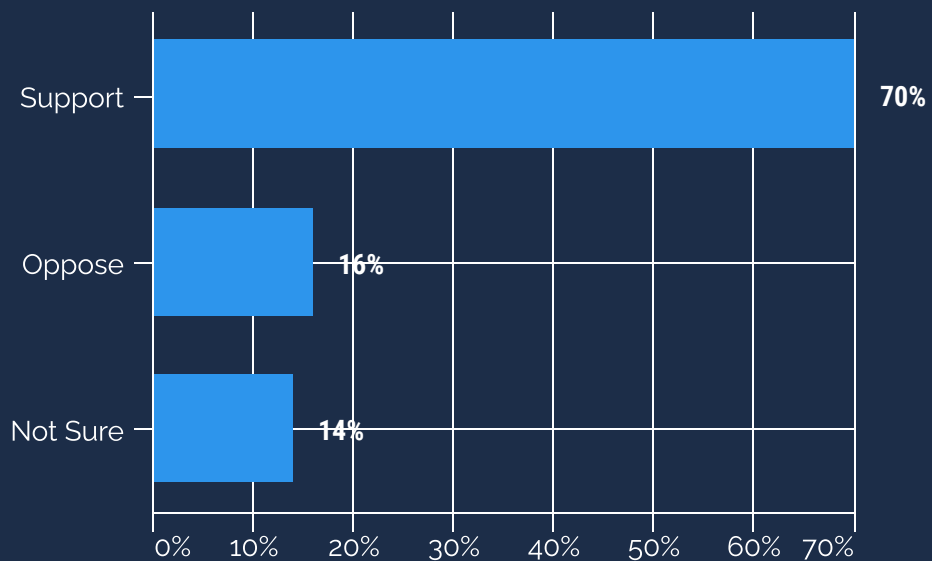

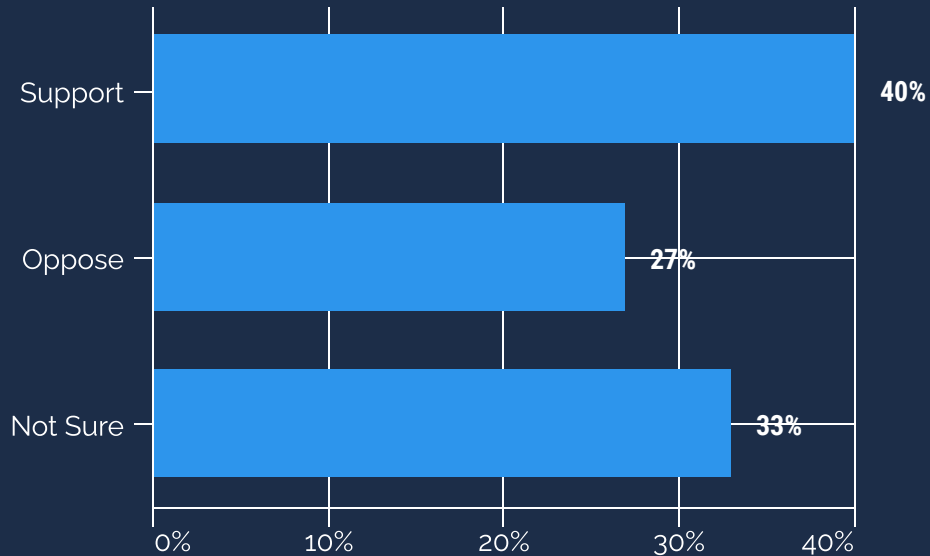
